**ADDENDUM NUMBER 1 TO THE REQUEST FOR PROPOSALS FOR SERVICE PLANNING AREAS 2-8 HIV/AIDS CORE MEDICAL SERVICES RFP #2010-02**

Addendum Number 1 constitutes a written addendum to the Request for Proposals (RFP) for Service Planning Areas 2-8 HIV/AIDS Core Medical Services RFP #2010-02.

Pursuant to RFP Subsection 6.1, this RFP is being withdrawn, effectively immediately, following technical inquiries received at the Proposer's Conference and written questions received by the March 12, 2010, deadline.

The Office of AIDS Programs and Policy (OAPP) intends to reissue the RFP as RFP #2010-03 (Re-Bid) during the week of March 22, 2010. The RFP Re-Bid will clarify the RFP requirements that specifically pertain to the proposer's minimum mandatory requirements; service category payment methodologies; jail-based HIV care services; data reporting requirements; page limit requirements and the use of Ryan White dollars as the payer of last resort. The reissued RFP will include an extended proposal submission period and will also provide information pertaining to a Proposer's Conference, the date to be announced in the reissued RFP.
