SUBJECT: CHDP PROVIDER UPDATE #03:15

I. <u>Update: Current Referral Recommendations for CHDP Gateway Denial of Presumptive Eligibility</u>

As noted in the previous CHDP Provider Update (#02-15), there has been a change in Presumptive Eligibility (PE) determination for Medi-Cal/CHDP. This change became effective July 31, 2015, and is reflected in a new CHDP Gateway message that your office may see upon enrolling a patient:

You are not eligible for PE because you have already received 2 PE enrollments within the past 12 months. Children under 19 years old are limited to two PE enrollments within the past 12 months.

Upon receiving this message, the child is not eligible for any CHDP services that day, regardless of visit type. This applies to all services, including: a regularly-scheduled periodic visit; a recheck or partial screen as follow-up from a previous visit; or a Medically Necessary Interperiodic Health Assessment (MNIHA), such as a school physical or sports examination.

In Los Angeles County, you may assist families in acquiring free or low-cost health care coverage for children by following the steps below:

- 1) Encourage the family to complete their Medi-Cal application, if they haven't already done so.
- 2) Refer the family directly to the programs listed in the table below. These programs assist families with enrollment in free or low-cost health coverage for those children who don't qualify for Medi-Cal or other health insurance. Information handouts for these programs can be found at the respective links below, and are also included as attachments to this Provider Update.
