



Percent of Total Live Births by Service Planning Area (SPA) Los Angeles County, 2004



Percent of Total Live Births by Mother's Trimester Prenatal Care (PNC) Began and by Mother's Race/Ethnicity Los Angeles County, 2004







Percent of Total Live Births by Source of Payment for Prenatal Care (PNC) and by Mother's Race/Ethnicity Los Angeles County, 2004







Percent of Total Live Births by Mother's Trimester Prenatal Care (PNC) Began and by Service Planning Area (SPA) Los Angeles County, 2004






Percent of Live Births to Mothers Less Than 20 Years of Age by Parity and by Mother's Age Los Angeles County, 2004

Note: Currently, there is no standard definition of or reporting system for domestic violence. Domestic violence is a complex issue involving many social and psychological forces. Therefore, reliance on a single indicator does not present a complete picture of the problem. To begin addressing these barriers, it is important to identify the existing data sources and understand their advantages and limitations. Local police jurisdictions's mandated reporting on "domestic violence-related calls for assistance" is one data source commonly used to describe the frequency of domestic violence in California, because it is population-based and easily accessible. However, these data only illustrate local law enforcement practices and response to domestic violence calls and are not an adequate source for measuring either the prevalence or incidence of domestic violence injuries.













KOTELCHUCK INDEX FOR PRENATAL CARE

To classify a mother's prenatal care history, Kotelchuck first determines the "expected number of visits" based on the gestational age of the infant and the month care began:



Note 2 -- The Kotelchuck index is computed only when the gestational age can be calculated from the date of birth minus the "date last normal menses began" as entered on the birth certificate. I.e., it is not computed from estimated gestational age.
