- Current PAC members will have membership extended by one year



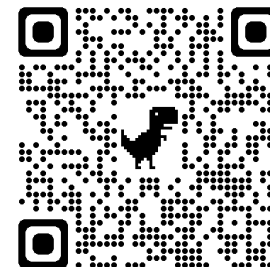

Recovery Bridge Housing and Recovery Housing Expansion

	Recovery Bridge Housing	Recovery Housing
Goal	2300 beds	500 beds
Current Capacity	2009 beds	174 beds
SPA Expansion Focus	1,2,4,5,6	1,3,5,6

- RBH/RH funding is subject to County/State budget changes
- Contact Homeless Services Unit – DPH-SAPC_HSU@ph.lacounty.gov to discuss expansion of RBH/RH
- Costs/expenditures prior to SAPC’s approval are not eligible for reimbursement



Homekey+ Permanent Supportive Housing

- Homekey+ is a housing initiative aimed at expanding permanent supportive housing (PSH) opportunities.
- SAPC has committed \$5M/year to fund up to 120 units for rental subsidies and SUD-focused Supportive Services (SUD-SS).
- Onsite Intensive Case Management Services (ICMS) will be available on a voluntary basis by the Homekey+ approved ICMS provider.
- Referrals will be submitted by SAPC Housing Navigators working with RBH/RH clients.
- A SAPC Information Notice will be released this month launching Homekey+

SAPC's Homekey+ Eligibility Criteria

Client must meet **ALL** of the following:

- Age 18 years or older
- Resident of Los Angeles County
- Experiencing homelessness, as defined by HUD:
 - Literally homeless;
 - At risk of homelessness;
 - Fleeing/attempting to flee DV; or
 - Homeless under other federal statutes
- Living with a Behavioral Health Challenge
- Has an annual income at or below 30 percent of Area Median Income (AMI)
- Received SUD services within the SAPC network in the last nine (9) months
- Currently working with a SAPC Housing Navigator
